## Proceeding of Research Extension meeting at KrishiVigyan Kendra, Jajpur

The Research Extension Linkage Meeting was conducted at KVK, Jajpur Barchana on 18.07.2017 (FN). Senior Scientist & Head KVK, Jajpur welcomed Deputy Director Of Agriculture, District Fishery Officer, Assistant Director of Horticulture, Senior Scientist of RRTTS, Ranital, DDM, NABARD & officers of agriculture and allied department & farmers. She requested Deputy Director of Agriculture, Jajpur to chair the session.

Senior Scientist & Head discussed about the paddy seed distribution in module villages as per the action plan prepared. She requested all the officials of line department to work in convergence mode for doubling of farmer's income. She requested all the members of the house to give their valuable suggestions to carryout different activities for doubling of farmer's income.

Deputy Director of Agriculture, Jajpur discussed with farmers about their previous financial status and present status after one year interventation. Deputy Director of Agriculture suggested joint field visit of all department officials to the five module villages in a convergence mode for better work. Action plan for doubling farmer's income in five module villages has been given to Deputy Director of Agriculture & Assistant Director of Horticulture Jajpur.

Beneficiary list of five module village has been distributed to all line department officials of the meeting as per the suggestion of Deputy Director of Agriculture.

Assistant Director of Horticulture Jajpur suggested for crop diversification. He advised the farmers to cultivate high value crop like tomato, colocassia which is having high market demand and high remvoeration. ADH also advised for potato cultivation and storing it in cold storage for getting higher profit in lean period. He has suggested to provide project proposals for cultivation of different high value crops on cluster basis.

As cucurbitceae crops required less input and less labour can be included in cropping system. Early off season crops will increase income of the farmer. He also advised farmers for banana cultivation and to cultivate yam etc as intercropping.

DDM, NABARD discussed about Pradhan Mantri Fasal Beema Yojana. He explained about different positive sides of the yojana. He expressed all official procedures for enrolling in Pradhan Mantri Fasal Beema Yojana to the house.

DDM, NABARD suggested farmers go for off season vegetable and high value vegetable cultivation. He also advised for potato cultivation. He advised farmers to calculated in staring potato in cold storage and selling during high demand lean and crop. He also cited different examples for encouraging the

farmers for vegetable cultivation. He also stressed on mushroom cultivation for getting higher income. He also requested the farmers to keep record of their cost of cultivation for calculation of cost economics. He also suggested the scientist of KVK to provide different project proposal.

District Fishery Officer, Jajpur also told to work in a convergence mode Field visit to be made jointly by officials of line department. For encouraging farmers of module village exposure visit to different successful entrepreneurs must be conducted. He also explained about the schemes of fishery department. He proposed to conduct Research Extension Meeting in the field of successful entrepreneur.

Dr. Gourishankar Singh, Senior Scientist of RRTTS, Ranital suggested the farmers to discuss with scientist of KVK relating to all agriculture problems. They should contact the scientist first and this purchase insecticide or pesticide for application of at correct time & in correct dose.

All the farmers shared their experience for the first year programme. Mr. Laxmidhar Rout of village Dihakuransa told that he has gained some extra profit for poultry and vegetable from the intervention made by KVK.

Mr. Harekrushan Rout of village choromuha told that production has increased by the scientist intervention.

Mr. Brahamananda Mallick of village Jari told that there is lack of cold storge facility in their locality and marketing facility is also not developed.

DDA, suggested that to three nos of cold storage will be constructed very soon. So the problem will be subsided.
