

Proceeding of 20th Research Extension & Entrepreneurs Linkage meeting at Krishi Vigyan Kendra, Jajpur

The 20th Research Extension Linkage Meeting was conducted at KVK, Jajpur Barchana on **20.02.2018 (FN)**. Welcome address was given by Senior Scientist & Head.

Senior Scientist & Head discussed about the work done in five module villages in brief and asked the farmers about the problems they are facing and about their activities.

Mr. Bibhubrata Rout, farmers of village-Dihakuransa, Block-Rasulpur told that they have developed 6 nos. of vermin-compost pit. They are getting more yield marigold by using sea weed extract. From one acre of land the farmers are getting weekly 2.4qtl marigold.

Mr. Santanu Mohanty, farmer of Choromuha village told that potato is in harvesting stage. Growth of poultry breed pallishree very good weight average. Mr.Niranjan Padhi, farmer of Choromuha village told that Tomato BT-136 is yielding good till he has harvested 1.5qtl tomato form 0.12 acre land & the fruit rind is thick and has more self life.

Assistant Horticulture Officer, Badachana suggested the farmers to do shed net house and polyhouse for off season vegetable cultivation and mushroom cultivation. He also told about different scheme of horticulture department. He

suggested to enroll the farmers for protected cultivation training before take up off season cultivation.

Mr. Pratap Kishore Khamari, SDVO, Jajpur suggested the farmers for deworming the animals and birds timely. He also discussed about different schemes of veterinary department. He suggested the farmers for low cost shelter house for animals and birds. He also suggested farmers to go for fodder cultivation and enrolled there name in different scheme of fodder.

Asst. Soil Conservative Officer also discussed about different schemes of department. He stressed on water harvesting structure for recharging of ground water as well as to use the collected water at the time of critical stages of crop growth during water stress period.

DAO, Jajpur discussed about different schemes of Agriculture department. He told the farmers to create farmers ID for getting benefit of Government subsidy.
